## Appendix P – Public Meetings

This appendix (Appendix P) includes details on the two public meetings held on February 26, 2020 and October 19, 2022. The focus of the meetings was to keep the public informed regarding project details and to receive public comments on the proposed action. Both meetings were held at the Air Zoo Aerospace & Science Museum (approximately 1.2 miles from the Airport) and were "drop in" events, allowing attendees to arrive any time between 5:30 PM and 7:30 PM. 
